# PARKER PROJECT OPPOSED BY SBAS

On March 12, the residents of Santa Barbara will have the opportunity to vote in a special election on the Hotel and Convention Center proposed for construction on East Beach by Fess Parker. After thorough consideration of the project, the SBAS board of directors urges a no vote on this matter.

Our reasons are many. While the current project is by far the best that has been proposed, it still contains numerous features we believe are detrimental to Santa Barbara. The size of the project is still such that a large increase in demand for our limited water supplies will result increasing pressure for importing water to our region (an expensive, growth inducing proposition).

This is but one of several such large projects proposed for our area. Passage of one sets a precedent for the others. The result could be expansion of the airport into what remains of the Goleta Slough to accommodate the guests of the national and international conferences for which these projects are designed.

East Beach is already suffering from traffic congestion and parking problems that can only be aggravated by the addition of such a large project making our beaches less accessible to the residents of Santa Barbara.

While a need for convention facilities exists in Santa Barbara, the need is not for the type of facilities the Parker project would provide. Few if any local (con't. on pg. 4)

# BIRDS IN SANTA BARBARA By Paul Lehman

Highlights of the winter season after the Christmas Bird Count includes an unprecedented five immature Glaucous Gulls at Lompoc, all attracted to a local garbage dump. Normally we record only about one individual per year. In Santa Barbara, the wintering Greater Peewee, two Grace's Warblers, and Virginia's Warbler were all still present in February. A Warbling Vireo there was excellent for this time of year. Orchard Orioles and White-winged Doves in Goleta were also of significant interest. A White-winged Scoter on Lake Cachuma was exceptional for this inland lake, and 100 Wood Ducks there was an outstanding

Lastly, this winter has seen record invasions of Mountain Bluebirds and Red Crossbills to our region, with many small flocks and individuals scattered about the area.

### DICK SMITH SCHOLARSHIP

Once again it is time to begin the selection process for the Dick Smith Scholarship to the Audubon Ecology Camp of the West. We urgently need your help in securing top candidates for this \$575 award. Nominees need not be Audubon members.

In past years these scholarships have enabled teachers, rangers and writers to attend the camp, people who would otherwise not have been able to go, yet were in good positions to promote the cause of conservation of our natural resources. The scholarship covers all costs for one of the four two-week sessions, except transportation to and from the camp.

It is our aim to find candidates who have a strong interest in ecology and conservation, who have a background to gain much from the camp, and who offer promise of using the training to advance the cause of conservation. We therefore request that the following information be provided for each nominee: (1) evidence of interest and activity to date, (2) evidence of ability to profit from the camp training, (3) ways in which the training would be passed back into our community, and (4) financial need, if any.

organizations require space for 1,000 or more people the Parker Project would be designed to serve.

In addition, the project would put additional strain on the limited available housing as workers are drawn into the area. Much of the mountain views of East Beach would be blocked by the building. The list of certain and potential problems goes on and on.

We recognize that the position adopted by our board does not represent that of many of our members and other community leaders. We also feel that the proposed project is by far the best that has come forth. Be that as it may, it is our position that on balance, the project as proposed will have a serious and detrimental effect on our community and local environment. We therefore urge a no vote on March 12, a move that will insure that a more appropriate, less harmful use of the project area will be found. # FIELD TRIP REPORTS



Lake Cachuma - Feb. 3

13 people braved cold and winds but found it well worth while. Highlights included an adult Bald Eagle and 5 White-fronted Geese. Also seen were numerous Goldeneye ducks and several Common Mergansers. One Lewis' Woodpecker was seen. Ospreys were common and pairing. Nesting of these birds at the lake seems imminent.

North County - Feb. 9

The "cancelled" Carrizo Plains trip. An alternate trip had been planned in case of wet weather, which we had. Saturday morning at 5:00 O'clock, the stars were out and it was cold. The first stop was at Lompoc to see some gulls. We had to wait for the sun to come up, but the gulls were found at a small athletic field west of town. A number of Herring and Glaucous-winged gulls were seen in a flock of about 700 birds. Most unusual was a wayward Ross' Goose in the flock. Regrettably, no Glaucous or Thayer's Gulls were found. People walking dogs did scare up the flock about five times until the birds finally gave up and moved on.

The next stop was west of Santa Maria, via the Casmalia Road. A Ferruginous Hawk and many shore birds were seen. They included Long-billed Curlew, both Yellowlegs, Dowitcher, and Black-bellied Ployer. Also, a flock of Canvasbacks were seen on a small reservoir.

The Cuyama Rd. had few places to turn off and stop, but Cottonwood Canyon Road was beautiful and interesting. The hills were grass covered and almost treeless. Raptors seen were Great Horned Owl, Red-tailed Hawk, Kestral, Merlin, and Cooper's Hawk. Other birds seen were Red-breasted Sapsucker, Phainopepla, Vesper Sparrow, and Savannah Sparrow. A flock of Horned Larks was joined by a flock of House Finch. The rattle of Longspurs was heard but the bird was not seen. The return trip was through the hills to Sisquoc, then to Los Olivos on Foxen Canyon Rd.

Figueroa Mountain - January 26

A dozen Auduboners joined in this trip to one of the high peaks of the county. We stopped first at Lake Cachuma for some distant looks at Canadian Geese, Bald Eagle, Osprey, and a great variety of ducks.

Moving on to the mountain, the diversity was a little disappointing but the species seen were almost all exciting. Raptors abounded including Ferruginous Hawk, Prarie Falcon, Merlin, Red-shouldered and Red-tailed Hawks, Turkey Vultures, and Kestral. At the top of the mountain Red Crossbill were seen along with Pygmy Nuthatch, Mountain Bluebird, White-throated Swift, Hairy Woodpecker, and Raven. As usual, the top also afforded great views of the sweep of the San Raphael Wilderness, a great lunch stop.




# VOLUNTEER OF THE MONTH


